The Office of Legal Affairs of the United Nations presents its compliments to the Permanent Missions and Permanent Observer Missions to the United Nations and has the honour to inform their Governments that applications are now being accepted for the 2018 Hamilton Shirley Amerasinghe Memorial Fellowship on the Law of the Sea.

The purpose of the Fellowship is to assist candidates who possess a degree in Law, Marine Sciences, Political Science, Ocean Management or technical training in Ocean Management, Administration of Ports or in related disciplines to acquire additional knowledge of the United Nations Convention on the Law of the Sea, in order to promote its wider appreciation and application, and to enhance specialized experience in those fields. Candidates must be citizens of developing States and be between the ages of 25 and 40 years and have a minimum of five years work-related experience.

It would be greatly appreciated if the call for applications is brought to the attention of eligible candidates by publicizing it as widely as possible and further circulating it to relevant government agencies, etc.
