

## INFORMATION NOTE TO PARTIES

Nomination of candidates for appointment or election during the United Nations Climate Change Conferences to be held in 2023

This is to inform Parties to the United Nations Framework Convention on Climate Change, the Kyoto Protocol and the Paris Agreement that nominations of candidates are invited for positions open for appointment or election during the United Nations Climate Change Conference to be held in Bonn, Germany, from 5 to 15 June 2023 and Dubai, United Arab Emirates, from 30 November to 12 December 2023, on the following bodies:

- · Bureau of the Conference of the Parties, the Conference of the Parties serving as the meeting of the Parties to the Kyoto Protocol and the Conference of the Parties serving as the meeting of the Parties to the Paris Agreement;
- Bureau of the Subsidiary Body for Implementation;
- Bureau of the Subsidiary Body for Scientific and Technological Advice;
- Adaptation Committee;
- Adaptation Fund Board;
- Advisory Board of the Climate Technology Centre and Network;
- Consultative Group of Experts;
- Executive Board of the clean development mechanism;
- Executive Committee of the Warsaw International Mechanism for Loss and Damage associated with Climate Change Impacts;
- Katowice Committee of Experts on the Impacts of the Implementation of Response Measures;
- Kyoto Protocol Compliance Committee;
- · Paris Committee on Capacity-building;
- Standing Committee on Finance;

Parties are invited to recall decisions 23/CP.18, 3/CP.23 and 3/CP.25 and to make additional efforts to improve the participation of women and achieve the goal of gender balance in bodies established under the Convention, the Kyoto Protocol and the Paris Agreement. As at 13 April 2023 a gender composition of 37 per cent female and 63 per cent male had been reached for membership of these bodies.
